### ► RADD-CPA Participant Code of Conduct

Recreational Activities for the Developmentally Disabled-Cerebral Palsy Agency of Racine (RADD-CPA) prides itself in sponsoring high quality recreational activities for children and adults with disabilities. The primary purpose of this code of conduct is to establish a high standard of participant behavior, which will ensure the safety and well-being of all participants involved in recreational activities. All participants are expected to abide by the Participant Code of Conduct as established by RADD-CPA. Participants should be reminded that participation in RADD-CPA Activities is a privilege, not a right, and that the Agency and Board of Directors has the authority to make immediate accommodations until final decisions can be made.

As participants of the Recreational Activities for the Developmentally Disabled-Cerebral Palsy Agency of Racine, each participant agrees to adhere to the following behavior statements:

- I will use respectful communication with staff, volunteers, and other participants.
- I will act in ways that bring respect to me, my staff, and fellow participants.
- I will not use bad language.
- I will not swear or insult other people.
- I will not fight with other participants, volunteers or staff.
- I will listen to my staff and ask questions when I do not understand.
- I will not make inappropriate or unwanted physical, verbal or sexual advances on others.
- I will not steal another participant, volunteer, or staff's property.
- I will not bring weapons or items that look like weapons (knives, water guns, etc.) to any RADD-CPA activities.

### Participant Standards of Behavior

The following participant behavior is unacceptable while participating in Recreational Activities for the Developmentally Disabled-Cerebral Palsy Agency of Racine Activities:

- Profanity or verbal abuse
- Tobacco use
- Use of alcohol
- Physical or verbal altercations
- Physical abuse
- Sexual abuse
- Violent or disruptive behavior
- Any unwanted physical contact
- Possession or harmful weapons



## Guidelines for Limiting or Denying a Participant’s Involvement in RADD-CPA Activities

RADD-CPA may limit or deny a participant’s participation in RADD-CPA activities based on the following, as determined by RADD-CPA in its sole discretion:

1. Admission of involvement in abuse, neglect, assault, or conduct involving violence or the threat of violence
2. Record of being charged with abuse, neglect, assault, or conduct involving violence or the threat of violence
3. Extreme or repeated violations of the RADD-CPA Participant Code of Conduct
4. Current use of illegal drugs
5. If the safety of other participants is at risk

**\*\*\*Not all situations or circumstances can be addressed in these guidelines, RADD-CPA will address each situation on a case-by-case basis.**

RADD-CPA recommends all participants and guardians review, understand, and sign the RADD-CPA Participant Code of Conduct before registering and participating in activities. If the participant is involved in multiple activities across all seasons, he/she need only to submit one form per year. RADD-CPA will retain a copy in the office files throughout the year.
